IT HAS ASSISTED 1,319 VICTIMS OF DOMESTIC VIOLENCE AND 206 VICTIMS OF SEXUAL ASSAULT. THE PROGRAM HAS PROVIDED SHELTER TO 158 WOMEN/MEN AND 75 CHILDREN FOR A TOTAL OF 6,930 NIGHTS OF SHELTER.
